OWNER: The Gerald R. Ford International Airport Board, Grand Rapids, Michigan, hereby gives notice that sealed Lump Sum Bids will be received for monument signs at the Gerald R. Ford International Airport, 5500 44th Street S.E., Grand Rapids, Michigan, 49512. The proposed construction includes monument signs and related items as shown on the Drawings prepared by TowerPinkster.

The work generally includes:

1.
 - a. Construction of monument signage including cast-in-place concrete, cast stone masonry units, metal framing, metal composite material wall panels, dimension letters, and other related items.

TIME AND PLACE OF BID OPENING: Sealed Bids will be received until 2:00 p.m., Local Time on the 12th day of May, 2017 in the office of the Gerald R. Ford International Airport Authority (GRFIAA), 5500 44th Street SE, Grand Rapids, Michigan 49512, located on the second floor of the Terminal Building. After the official Bid closing time, the Bids will be publicly opened and read aloud in the Gerald R. Ford Room, located on the second floor of the Terminal Building.

FUNDING: The work to be performed under this contract will be financed and paid for from local funds.

BID SECURITY: Bid Security in the amount of not less than 5% of the Bid shall accompany each Bid in accordance with the Instructions to Bidders.

CONTRACT SECURITY: The Bidder to whom a Contract is awarded shall furnish a Performance Bond and Payment Bond each in an amount equal to the Contract Price.

BID REJECTION/ACCEPTANCE: Owner reserves the right to reject any and all bids, waive informalities in bidding or to accept the Bid or Bids which best serve the interests of Owner.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of 45 days after the opening of the Bids without the consent of Owner.
